I write to you with a heavy heart. On April 17th my brother Gary, a Past Supreme Exalted Ruler, Honorary Active in Zeta Tau, Sigma Rho of an Abbie winning chapter passed away at the age of 55. He passed away from a heart attack and leaves behind a son, Robert.

I was blessed to have spent the usual brother relationships such as being best man at each other's weddings, sharing a room as kids, spending vacations together among others. However because of Sigma Alpha Rho we had an additional bond that was truly special. Our careers in SAR were very similar.

Gary followed me as Sigma Rho of Zeta Tau. He led that chapter to an Abbie. He was awarded Honorary Active in Zeta Tau for his efforts. He went on to serve as Exalted Ruler of PDC the year after I held that position. He also received Honorary Activity in PDC.

Following a successful term as ER, he became Supreme Exalted Ruler immediately after I left office. He serviced one term and then years later Gary was asked to return to help SAR by assuming the role once again. Gary was awarded International Honorary Active following his first term as SER.

The fact that Gary followed a lot of what I did not only in SAR but other endeavors is not lost on me. It is very special when someone decides that there is someone they admire and love so much that they

want to emulate them and follow in their footsteps. I probably did not appreciate that enough and only now after he is gone the reality of that fact has made his loss that much greater.

Gary continued to serve SAR as he was an active board member of the Alumni Association. His involvement will be missed especially as we are approaching our 100th Anniversary.

SAR had a great effect on Gary's life. It helped him mature and turn into a leader not only in SAR but other endeavors including his long affiliation with Golden Slipper Camp. The friends Gary made in life was evident of the over 500 mourners at his funeral. The amount of messages on Facebook from his friends and the words of loss and comfort were truly inspiring.

It is my intention to create a Rathblott Scholarship in Gary's name. Past President Jerry Segal has made the first contribution and if you would like to make a donation please send a check to "Rathblott Scholarship Fund" and mail to Alumni Treasurer, Jerry Jaffe. Jerry's address is on the dues form. Also honor Gary by increasing our membership so that when we celebrate our 100th Anniversary in October, 2017 we will have the largest membership of any Jewish men's organization.

Gary will be missed and he will be remembered for all he did in life and a very successful career in Sigma Alpha Rho.

Rocky transferred to Sigma and was elected the group's Sigma Rho. Rocky was always proud to wear his Sigma Alpha Rho jacket to all of the SAR Reunions (and it still fit).

I knew Irv Karpf as he and his wife Joan were next door neighbors (70's & 80's) and very good friends with my aunt and uncle. I saw and knew Irv before either of us knew that we were SAR brothers. At the 75th Reunion, we saw each other on the parking lot before entering the Reunion. As we approached, Irv's greeting was "Hello my Brother".

It is my sincerest hope that as editor I will not have to be the bearer of bad news on Past SER's or Alumni Board Members in future Newsletters. I enjoy sharing the good news of Brothers accomplishments and Alumni happenings. I wish good health to all and will speak to you in the next Newsletter.
