## In Memory

### CHARLES J. BOGDANOFF

Brothers,

This will be the most difficult thing that I will have ever written. I really have no idea on how or where to begin. I will do my best, but whatever I write will not be enough for this newsletter.

Charles J. Bogdanoff passed away after a long illness on June 8, 2015. Charles died peacefully in Philadelphia and leaves behind his wife Shirley and children Michael, past SMR, and daughter Michelle. He also had 5 grandchildren.

I met Charles when I was 18 years old in 1970. Charles, Jerry Krader, Whitey Weissman and Jerry Schaefer made an agreement to mentor 2 young Brothers each and they would commit themselves to save the fraternity. The fraternity was going through hard times and these Brothers had a plan. Jerry Krader came back to be SER and the 8 of us became trainees. We were on a mission to rebuild the fraternity.

Charles started his mentorship with me on day 1. Literally, every week he drove me from chapter to chapter. We went to Allentown, Brooklyn, Wilmington, Cherry Hill and on and on. We flew to Montreal and visited 5 chapters located there. He was relentless and I was the benefactor. I watched and listened to him. I heard him settle arguments. I noticed how he read Brothers. He could tell who was for real and who was not. I watched him receive standing ovations after giving chapters pep talks. I always said I wish I could do that.

Charles did not start or end with me. He became SER in 1958. For the years before that he worked tirelessly for his beloved Omega Chapter. He rose through the ranks and eventually became President of the entire fraternity.

Most Brothers enjoy an incredible fraternal career and then move on. It's college, marriage, job, children, etc. Charles never moved on. Just ask Zev Rose. Zev recently told me that Charles was his INSPIRATION. He said he would never have been SER if it wasn't for Charles. He clicked with Charles and Charles played a major role in his presidency. Zev became SER in 1960.



Charles' activity continued in the 60's and from 1970-2015. He had his hand in every generation since the 50's. Charles played a major role with every SER. He managed to juggle his life and job and to call every SER 3 or more times a week. Charles shared his knowledge and helped guide each and every one. He wasn't just interested in their fraternal career but also in their daily life. He was the ear to talk to about college, a job, marriage, purchasing a business, preparing a will and again on and on. Past SER Michael Mendelson called him "a WISE man". Where Charles found the time to do all of

this, I will never know. He was the master of time management. He managed to run a successful law firm, be a devoted husband to Shirley, be a phenomenal dad to Michael and Michelle, be a proud pop-pop and spent enormous hours of time and energy with SAR. My one word for Charles is COMMITTED.

He lived day and night with SAR on his mind. I never met a Brother that has been this dedicated to SAR. He was Sigma Alpha Rho. He was the real father of SAR. He was a one of a kind and to all of us who had the good fortune to know him, we are forever blessed.

We owe it to Charles to keep SAR alive and growing. He was looking forward to the 100th Anniversary on October 15, 2017. I whispered in his ear the day before he passed away that we will have the best anniversary ever and to my fellow Brothers, in his honor and memory, let's make it happen. I can't seem to say goodbye Charles so I will simply say, we love you Charles. Thank you for everything. You did so much for so many of us. We will always love and remember you.
